Type 2 Child Restraint Fitting Stations (Fit child restraint anchorage points)

For the child restraint to function properly in a crash it is necessary for:

- The child restraint itself to be correctly fitted.
- The vehicle to have child restraint anchorage points safely located and fitted.

The “Type 1 Child Car Restraint Fitting Service” was set up to help assure that child restraints are correctly fitted. However, it is essential that child restraint anchorage points are correctly installed due to the large forces that are transmitted during a vehicle collision. For this reason the “Type 2 Child Restraint Fitting Station Scheme” has been set up to complement the “The Child Car Restraint Fitting Service”.

Child car restraint fitting service

“The Child Car Restraint Fitting Service” was launched in November 2005 and is currently administered by Roadwise. The Road Safety Council established the network of trained Type 1 Child Car Restraint Fitters throughout Western Australia to provide advice and assistance with the installation of child car restraints as well as providing information regarding the suitability of restraints according to the child’s weight and size. Type 1 Fitters may not modify a vehicle, that is, they cannot fit anchorage points to a vehicle, thus the need for this complementary scheme.

Type 2 Child Restraint Fitting Station Scheme

The Type 2 Child Restraint Fitting Station Scheme is a complementary scheme to facilitate easier, faster and safer installation of anchorage points. The Department has authorised Fitting Stations to install and to approve the installation of child restraint anchorage points to vehicles.

Under the scheme certain Department approved businesses are authorised to fit child restraint anchorage points and anchorage accessories. The businesses are known as “Type 2 Child Restraint Fitting Stations” and the officers approved to do this work are known as “Type 2 Fitters”. They are also able to approve anchorage points and accessories that have been installed by others, providing these installations are straightforward. No modification permit will need to be issued by the Department if an authorised modifier fits a modification plate.

Modification plate

Authorised Type 2 Fitting Station officers must affix this plate to a vehicle after they are satisfied that it complies with all required vehicle standards.
